The rates quoted should be for delivery of the articles at the place mentioned in the schedule. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of officer to whom the quotation is to be sent are also noted in the schedule. Any quotation received after the time fixed on the due date is liable to be rejected. The maximum period required for delivery of the articles should also be mentioned. Quotations not stipulating period of firmness and with price variation clause and/or 'subject to prior sale' condition are liable to be rejected.

The acceptance of the quotations will be subject to the following conditions:

1. The bid shall be submitted by the manufacturer having manufacturing facility / or their branch office in India either directly or through their authorized dealers with 1-year dealership with the firm.

2. The Department will qualify those firms/bidders who are considered most suitable for the supply under question. The selection will take into account the firm's/ bidders relevant experience in the manufacture and the supply of the quoted item.
3. The bidder should be in a position to assume, on a single point responsibility basis, the full obligation and responsibility for supplying the materials within the specified time schedule.
4. Firms offering the full quantity of item mentioned in the quotation alone will be considered. Bidders who are quoting part quantity will not be qualified.
6. The bidder should not have been Black Listed (De-barred from quoting further quotations) on the ground of poor performance/ poor supply records from any Indian utility/ test house.
7. Withdrawal from the quotation after it is accepted or failure to supply within a specified time or according to specifications will entail cancellation of the order and purchases being made at the offerer's expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the Government reserves also the right to remove the defaulter's name from the list of Government suppliers permanently or for a specified number of years.
8. Any attempt on the part of bidders or their agents to influence the Officers concerned in their favour by personal canvassing will disqualify the bidders.
9. In cases where a successful bidder, after having made partial supplies fails to fulfill the contracts in full, all or any of the materials not supplied may, at the discretion of the Purchasing Officer be purchased by means of another quotation or by negotiation or from the next higher bidder who had offered to supply already and the loss, if any, caused to the Government shall thereby together with such sums as may be fixed by the Government towards damages be recovered from the defaulting bidder.
10. The prices quoted should be inclusive of all taxes, duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or delivery during the course of execution of the contract.
11. Ordinarily payments will be made only after the supplies are actually verified and taken to stock.
14. Detailed and complete specifications of quoted items should be furnished along with the quotation schedule. Incomplete details shall liable to be rejected.
15. Any further information other than these contained in the offer, regarding specifications of the item quoted will have to be furnished, if called for.
16. All materials used should confirm to the relevant RoHS specifications.
17. The rates quoted should remain firm so as to cover the period required for the supply of the goods in good condition except for the changes in the rate of GST that may be effected by Government.
- 18. The goods should be supplied normally within 30 days from the date of placing firm orders. In the case of this is not possible the time required to complete the supply should be clearly indicated in the quotation.**
19. Those bidder without sufficient prescribed documents, shall be rejected summarily from this quotation.

20. Chief Electrical Inspector reserves right to withdraw quotation without any further notice.
